Schwalbach moved, Dixon seconded to accept the minutes of December 13, 2010. Motion carried.

1-1-11: Prater moved, Clary seconded to allow Jeremy Forcum to put up sign on motocross track from now until July 11. Motion carried.

1-2-11: B. Pickerrell moved, McCorkle seconded to allow Jeremy Forcum to put up vinyl banners for sponsors on motocross track 10 days prior and 2 days after the races. Motion carried.

1-3-11: Corcoran moved, B. Pickerrell seconded to allow Jeremy Forcum to have a Beer Garden on race dates. Motion carried.

The Ross County Commissioners budget includes \$53,300.00 for the 2011 fair; \$3300.00 for premiums, \$37,500.00 for fair debt, \$12,500.00 for agricultural grant.
