The Pledge of Allegiance was led by Prater.

Election of Officers

11-1-20: Bethel moved, Chrisman seconded to nominate Gary Prater for President. Nelson moved, Clary seconded to nominate Brad Cosenza for President. McCorkle moved, Hurtt seconded to close the nomination for President. Cosenza was voted President by a fourteen to four vote. Bethel moved, Whitten seconded to nominate Gary Prater for Vice President, Prater declined. Cosenza moved, Clary seconded to nominate Steven Clever for Vice President. Cosenza moved, to nominate Barry Haubeil Jr. for Vice President, Haubeil Jr. declined. Steven Clever elected Vice President by acclamation. Motion carried.

Brian Miller with Miller Automotive Swap Days discussed the process that he is taking with the Ross County Health District concerning his event. He has met with them and they will be on site before the event opens to approve his plan.

4-H Report

Aaron Swepston reported that they have had a county wide 4-H Zoom Meeting with an attendance of 220-245. They will be conducting meetings in this manner monthly.

Jr. Fair Report

Wells has requested six dates to use the Multipurpose Building for Jr. Fair workdays.

11-2-20: Free moved, Cosenza seconded to permit Wells to use the Multipurpose Building for the six Jr. Fair workday meetings. Motion carried.

Discussion was held on changing the way that animals move into the fair, two Veterinaries would have to be present. The process would be the same as used this year. There were concerns if this would work during a full fair.

Wells suggested that exhibitors be permitted to bring two different species of market animals to the fair. Only one animal would go thru the sale arena, unless both animals had won grand or reserve champion, the other animal would be sold at market price. Dairy Projects would like to take a product of their project thru the sale arena. Clary suggested that a booth be set up to sell dairy products or another suggestion was to have a milk shake stand. The swine rule on the process of trimming the project has been changed to state that only the ears and tail can be clipped before the fair and not on the fairgrounds.

11-3-20: Hurtt moved, Free seconded to accept the change in Swine Hair Trimming Rule to remove trimming of the face from the rule. Motion carried.

Sales Committee Report

All but four to five buyers have paid their invoices. All premium checks have been sent to exhibitors.
