Andy Wettersten spoke on the invoice from Swango. The remains of the Grant for installing Wi-Fi to the Midway and Buildings will be used to install a box on each electric pole in one row of camping as a test to see if the wi-fi will work during the fair. The Commissioners have approved using the rest of the grant money for this. A 110 electric outlet will have to be installed on the electric pole also.
